

Terms and Conditions

Shop to Win Groceries for a year Competition – SA Permit T24/1793

1. Introduction

- All entrants will be subject to and will need to adhere to the terms and conditions as set out by the Promoter and any future terms and conditions or alteration to these terms and conditions.
- To enter the competition, entrants must spend \$10 or more at any Gawler Green retailer, complete the online entry form and upload a proof of purchase.

2. Prize: The promotion prize has a total value of \$9100.00 and consists of the following:
